

where the boundary which divides the said parish of Newton Ferrers from a detached part of the parish of Holbeton crosses the road from Creacombe Cross to Gala Cross and continuing thence southwards along the middle of the said road to the road junction at the northwest corner of close No. 6383, thence generally southwards along the middle of the road which runs along the western edges of close Nos. 6383, 6271 and 6752 to the road junction at the southern corner of close No. 6752, thence along the middle of the road which runs along the western edge of close Nos. 8442, 9347 and 8533 to the boundary which divides the said parish of Newton Ferrers from the said detached part of the parish of Holbeton.

"4. The territory to be annexed to the parish of Holbeton:—

"(a) All that part (coloured pink on the map lettered B annexed hereto) of the parish of Newton Ferrers which lies to the east of a continuous imaginary line commencing at a point on the boundary which divides the parish of Newton Ferrers from a detached portion of Holbeton in the middle of the road which runs along the western edge of close No. 9019 and continuing thence generally southwards along the middle of the said road to the boundary which divides the said parish of Newton Ferrers from the parish of Holbeton

"(b) All that detached part (coloured green on the map lettered B annexed hereto) of the parish of Ermington which lies to the west of the middle of the river Erme and which is bounded on the southwest, west, north, and part of the east by the parish of Holbeton and on the remaining part of the east by the parish of Ringmore with Kingston.

"5. The territory to be annexed to the parish of Ermington:—

"All that part (coloured brown on the map lettered B annexed hereto) of the parish of Holbeton which lies to the north of the Plymouth to Modbury Road (numbered A 379 on the map).

"6. The territory to be annexed to the parish of Revelstoke:—

"All that part (coloured pink on the map lettered A annexed hereto) of the parish of Holbeton which lies to the west of a continuous imaginary line commencing at a point on the boundary which divides the parish of Newton Ferrers from the parish of Holbeton in the middle of the road which runs along the western edge of close No. 9655 thence southwards along the middle of the said road to a point opposite the southwestern corner of close No. 9655, thence along the middle of the road which runs along the western edge of close No. 9745 and the northern edges of close Nos. 9338, 8929, and 7623, and along the western edges of close Nos. 7623, 7806, 7796 and 8179 and along the western and southwestern edges of close Nos. 9262 and 0353 to the road junction at the southeastern corner of close No. 0142 thence along the middle of the road which runs along the southern edges of close Nos. 0142 and 8943 to the road junction opposite the northwestern corner of close No. 9525 thence along the middle of the road which runs along the western edge of close No. 9525 to a point at the northwestern corner of close No. 9716 thence along the western edge of close No. 9716 and in a straight line in continuation thereof to the sea."

FACTORIES ACTS, 1937 AND 1959  
*Training in First Aid*

On 5th September 1960, the Minister of Labour made the Factories Act, 1959 (Commencement No. 3) Order, 1960 (S.I. 1611) bringing into force section 1, concerning cleanliness, and section 19, concerning first aid, of the Factories Act, 1959.

On the same day the Minister made the First-aid (Standard of Training) Order, 1960 (S.I. 1612). This Order prescribes the conditions that have to be satisfied before persons can be deemed to be trained in first-aid treatment for the purposes of subsection (3) of section 45 of the Factories Act, 1937, and, in the case of certain factories, requires the particulars relating to persons so trained to be entered in, or attached to, the general registers of the factories concerned. This Order, together with section 19 of the Factories Act, 1959, comes into operation on 1st July 1961.
