PUBLIC HEALTH ACTS AND CLEAN AIR ACT

COUNTY BOROUGH OF HALLIFAX

The Halifax (No. 3) Smoke Control Order, 1960

1. Notice is hereby given that the Council of the County Borough of Halifax in exercise of the powers county Borough of Hahitax in exercise of the powers conferred on them by section 1d of the Clean Air Act, 1956, on the 7th day of September 1960, made an Order entitled the Halifax (No. 3) Smoke Control Order, 1960, declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

2. Subject to the exemptions provided by virtue of section Ill (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emissions of smoke were not caused by the use of fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. If confirmed the Order will not come into opera-tion before 1st June 1961, or before a later date determined by the Minister of Housing and Local

Government.

4. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Halifax, at all reasonable times during the period of six weeks from the 16th day of September 1960.

5. Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the con-

firmation of the Order.
