

- Map No. 24. Add footpath from County road 41132 at Watermead in a general N. direction adjacent to the site of the Brockworth Industrial Hostel via O.S. Parcel Nos. 173, 148, 172 to the Gloucester—Cirencester Road, A.417.
- Map No. 24. Add footpath from the Cheltenham—Painswick road A.46 commencing at the same point as footpath EBW.30 proceeding in a N.W. direction via O.S. parcel No. 120 at Castle Hill, to join Green Street, County road No. 41104 at a point where it is joined by the road leading to Watermead.
- Map No. 24. Add footpath from the same point on the Cheltenham—Painswick road A.46 at Castle Hill as described above and extend in a W. direction via O.S. Parcel Nos. 120 and 121 to join Green Street, County road 41104 at a point approx. 200-ft. S.E. of the Congregational Chapel.
- Map No. 25. Add footpath from footpath EBW.24 approx. 100-ft. W. of its junction with footpath EBW.25 extending in a S. direction via O.S. parcel No. 78 to join County road, route No. 41134, opposite the foot of Coopers Hill cheese rolling slope.
- Map No. 25. Add footpath from the Cheltenham—Painswick road A.46 at a point opposite the Lodge of Well Close House extending in a general N.W. direction via O.S. Parcel No. 51 to the County road Route No. 3/217 which leads to Upton St. Leonards.
- Map No. 24. Realign footpath EBW.9 where it crosses O.S. field No. 217, such that it follows the track shown on a later edition of the 25 in. O.S. Map and enters Mill Street, County road 41129 at a point approx. 400-ft. to the E. of its present position.
- Map No. 24. Realign footpath EBW.35 at the N.E. end to join Greenstreet approximately 700-ft. S. of Pound Farm, via O.S. parcel No. 175b, to accord with the Diversion Order dated 11th November 1948, referred to in the statement annexed to the draft map.
- Map No. 24. Realign footpath EBW.37 such that it is located on the S.E. side of the field boundaries instead of on the N.W. side as at present shown.
- Map No. 24. Add footpath from the Gloucester—Cirencester road A.417 at the 'Butts' in general N.W. direction to join footpath EBW.10 approx. 300 ft. E. of Vicarage Lane, passing through O.S. parcel Nos. 205 and 217.
- Map No. 24. Add footpath from the Cheltenham—Painswick road A.46 from a point approx. 300 ft. N.E. of the Cross Hands, N.W. via O.S. Parcel No. 164 to the Estate road known as Wye Road.
- Map No. 24. Add footpath from Footpath EBW.9 at point approx. 1,160 ft. N.W. of its junction with the Cheltenham—Painswick road A.46. S.E. via O.S. parcel No. 215 to join the Estate road known as Humber Place.
- Map No. 24. Add bridle road from Upper Greenstreet route No. 41133 near its junction with Cheltenham—Painswick road A.46 to the point where it rejoins Upper Greenstreet, approx. 133 vds. further south.
- Map No. 23. Reclassify to a CRF. footpath EBR.7 from the Gloucester—Stroud road, B.4072, N.E. to the County Boundary with Gloucester City at a point approximately 700 ft. N.E. of White House, Whaddon.
- Map No. 23. Reclassify to a CRB. bridle road EBR.12 from the Brookthorpe—Sneedhams Green road near Ongers Farm N.W. to the point where it joins the unclassified road 51122, N.E. of Selfwood and Gilberts Cottage.
- Map No. 21. Reclassify to a CRB. footpath EBR.25 from Naas Lane in a general S.W. direction to the point where it joins footpath EQU.19 at the Parish Boundary.
- Maps No. 21 and 23. Reclassify to a CRB. bridle road EBR.28 from the Gloucester—Stroud road, B.4072 to the point where it terminates approx. 1,300 ft. N. of Bryercroft, Brookthorpe.
- Map No. 21. Add footpath from bottom of Toots Lane where it crosses Daniels Brook in a general S.E. direction along the N.E. boundary of O.S. 13 to join footpath EBR.21 near Field Buildings at a point 30 yds. N. of its junction with EBR.22.

*Parish of Churchdown*

- Map No. 12. Delete part of footpath ECN.3 from its junction with footpath ECN.9 E. via the yard of Pirton Court Farm to Pirton Lane.
- Map No. 14. Add footpath from Sandfield road Route No. 41103 in an E. direction to the Churchdown—Badgeworth road Route No. 3/80.
- Map No. 14. Add footpath from footpath ECN.35 passing under the Gloucester—Birmingham Railway Line in a S.E. direction to Brookfield Lane, Churchdown.
- Map No. 14. Add footpath from footpath ECN.40 at point where a track leads to Home Farm then in a N.E. direction via O.S. Nos. 148, 145 to join Badgeworth footpath ABA.8 at the Parish boundary.
- Map No. 14. Add footpath from footpath ECN.22 approx. 200 ft. S. of its junction with footpath ECN.21 S.E. via O.S. parcel No. 459 along Soldiers Walk crossing footpath ECN.42 and continuing S.W. to meet Hucclecote footpaths EHU.10 and EHU.11 at the Parish Boundary.
- Map No. 14. Add footpath from ECN.22 near the Church along the top of the S.E. Spur of Churchdown Hill to join footpath ECN.25a E. of Yewtree Cottage passing through O.S. Parcel Nos. 84, 83, 88, 95 and 97.
- Map No. 14. Realign the E. end of footpath ECN.22 to the S. side of the field boundary and thence to follow the enclosed path shown on the O.S. maps on the W. side of St. Bartholomews Church.

*Parish of Down Hatherley*

- Map No. 11. Realign footpath EDH.15 to commence in Down Hatherley Lane at a point approx. 100 ft. E. of its present position, proceeding in a S. direction to join footpath EDH.13.

*Parish of Eastington**Parish of Brookthorpe*

- Map No. 23. Delete that part of footpath EBR.8 which crosses O.S. 83. Incorporate footpath EBR.8a with the remainder of footpath EBR.8 and amend the statement annexed to the draft map accordingly.
- Map No. 23. Reclassify to a CRB. footpath EBR.5 from the Gloucester—Stroud road, B.4072, S. to the point where it joins CRB. EBR.6.

- Maps No. 30 and 32. Delete bridle road EEA.40 from a point on the Eastington—Whitminster road approx. 300 ft. S. of Westend Farm to the point where it rejoins the same road, approx. 700 ft. N.W. of Pike Bridge.
- Maps No. 30, 35 and 36. Reclassify to a CRB. footpath EEA.62 from Cress Green to a point approx. 600 ft. S.E. of Eastington House.
