WAGES COUNCILS ACT, 1959

### AERATED WATERS WAGES COUNCIL (ENGLAND AND WALES)

### HIGHWAYS ACT, 1959

#### *Borough of Lowestoft (Caldecott Road Railway Crossing) Public Path Creation Order, 1960*

Notice is hereby given that on 1st November 1960, the Minister of Housing and Local Government in pursuance of the powers conferred upon him by subsection (3) of section 29 of the above Act, made the above Order.

The effect of the Order is to create at the expiration of twenty-one months from the date of the Order a public footpath from a point on the south side of Hall Road, near its junction with Broad Road, leading in a southerly direction for a distance of 318 feet and passing under the railway line by means of a subway.

A certified copy of the Order and of the map contained in the Order made by the Minister has been deposited at the offices of the Lowestoft Borough Council, Town Hall, Lowestoft, and at the Ministry of Housing and Local Government, Whitehall, London S.W.1, and will be open for inspection free of charge during the usual office hours.

The Order becomes operative as from 18th November 1960, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may within six weeks from the date of publication of this notice make application to the High Court.
