The Order shall not prevent any person from causing or permitting a vehicle to wait for so long as may be necessary

- (a) to enable a person to board or alight from the vehicle: or
- (b) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of any of the lengths of road so referred to or the laying, erection, alteration or repair in or near to any of the said lengths of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or elec-Telegraph Act, 1878;
- (c) to enable goods to be loaded on to or unloaded from the vehicle: Provided that no vehicle shall wait to load or unload goods between the hours of 8.30 a.m. and 9.30 a.m.; 12.30 p.m. and 2.30 p.m.; and 5.30 p.m. and 6.30 p.m.; on any day other than Sunday.

CHEADLE AND GATLEY URBAN DISTRICT COUNCIL
