MERCHANDISE MARKS ACT, 1926

Report of the Standing Committee respecting imported P.V.C. sheeting, etc.

The Board of Trade hereby give notice that a Report has been made by the Standing Committee (General Merchandise) under the Merchandise Marks Act, 1926, in respect of imported goods of the following descriptions:

Sheeting from polyvinyl chloride and from polyvinyl chloride copolymers:—which term, sheeting, includes plates, sheets, strips, film and foil,—plasticised or unplasticised, in rolls or cut sheets and in any form or degree of surface or decorative finish, including, but not limited to, plain (matt or polished surface), printed, embossed and/or laminated, and with or without a protected or unprotected adhesive backing, and any rectangular articles cut therefrom, not further worked.
