The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under sections 1, 2 and 13 of the Import Duties Act, 1958, viz.: The Import Duties (General) (No. 3) Order, 1961.

This Order consolidates, as at 21st March 1961 the Import Duties (General) Order, 1958, and the various Orders amending it. It also takes account of the Import Duties (European Free Trade Association) Order, 1960, as amended, by setting out in a separate column in the Schedule to this Order the rates of import duty chargeable on goods grown, produced or manufactured in, and consigned from a place in, the European Free Trade Association Convention Area.

The Order comes into operation on 21st March 1961, and has been published as Statutory Instruments 1961, No. 403.
