MORLEY BOROUGH COUNCIL

*The Borough of Morley (Nos. 8, 9, 11 and 12) Smoke
Control Orders, 1961*

1. Notice is hereby given that the Morley Borough Council in exercise of the powers conferred on them by section 11 of the Clean Air Act, 1956, on the 22nd day of March 1961, made Orders entitled the Borough of Morley (Nos. 8, 9 and 11) Smoke Control Orders, 1961, and on the 29th day of April 1961, made an Order entitled the Borough of Morley (No. 12) Smoke Control Order, 1961, declaring the areas described in the Schedule hereto to be smoke control areas, which Orders are about to be submitted to the Minister of Housing and Local Government for confirmation.

2. Subject to the limitations and exemptions provided by the Orders and by virtue of section 11 (4) of the Act if, on any day after the Orders have come into operation, smoke is emitted from a chimney of any building within the smoke control areas the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. If confirmed the Orders will not come into operation before 1st January 1962, or before a later
