of the junction with the road leading to Capel Deunant (Class III/44);

- (iii) in that length of the Aberdaron-Rhiw Road (Class III/8) between the eastern gable wall of Ty Newydd Hotel and the eastern extremity of the graveyard of St. Hywyn's Church;
- (iv) in that length of the Aberdaron-Rhiw Road (Class III/8) on the northern side of the road along the length of the south side of The Ship Inn; and
- (v) in that length of the Aberdaron-Llanbedrog Road (B.4413) on the westerly side only between the south side of Pont Fawr and the northerly side of the private road leading to the Post Office.

(2) Cause or permit any vehicle to wait for a longer period than one hour at any one time or more than once in any consecutive period of two hours between the hours of 8 a.m. and 8 p.m.:

#### Road Traffic Regulation Order

- (d) to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
