FACTORIES ACTS, 1937 TO 1959

The Minister of Labour hereby gives notice that on 13th June 1961, in pursuance of Regulation 4 of the Operations at Unfenced Machinery Regulations, 1938, as amended by the Operations at Unfenced Machinery (Amended Schedule) Regulations, 1946, he made the Unfenced Machinery (Prescribed Leaflet) Order, 1961.

The purpose of this Order is to prescribe the precautionary leaflet to be supplied in accordance with the said Regulation 4 to every machinery attendant to whom the said Regulations apply. The Order amends the existing leaflet in order to make it a clearer and more accurate statement of the legal obligations imposed by the said Regulations.

WATER ACT, 1945

Statutory Orders (Special Procedure) Act, 1945
