FACTORIES ACTS, 1937 to 1959

Draft Special Regulations

In pursuance of section 129 of, and the Second Schedule to, the Factories Act, 1937, the Minister of Labour hereby gives notice that he proposes to make special regulations imposing requirements for the protection of persons employed in factories and other places to which the said Act applies, against ionising radiations arising from:

- (a) sealed sources; and
- (b) machines or apparatus intended to produce ionising radiations or in which charged particles are accelerated by a voltage of not less than five kilovolts.
