## TENDERS FOR TREASURY BILLS

1. The Lords Commissioners of Her Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 4th August 1961, at 1 p.m. for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939, to the amount of £250,000,000.

2. The Bills will be in amounts of £5,000, £10,000, £25,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Tuesday, the 8th August 1961, to Saturday, the 12th August 1961, inclusive, and will be due 91 days after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. Notification will be sent by post on the same day as Tenders are received, to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday, 11.30 a.m.) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of Her Majesty's Treasury reserve the right of rejecting any Tenders.

## The Surcharge on Revenue Duties Order, 1961:

This Order, which is made under section 9 of the Finance Act, 1961, imposes a surcharge at the rate of ten per cent. on amounts in respect of Customs and Excise revenue duties and Purchase Tax which become due on or after 26th July 1961.

## (b) Purchase Tax.

There is a corresponding ten per cent. increase from the same date in respect of drawbacks and similar rebates and allowances.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under sections 9 and 13 of, and the Fifth Schedule to, the Import Duties Act, 1958, viz.:

The Import Duty Drawbacks (No. 7) Order, 1961.

This Order—

(a) provides for the allowance of drawback of import duty—

(i) on the exportation of fresh grapefruit,

(ii) on specified imported cellulose paper used in the manufacture of certain exported recording paper,

(b) extends until 31st July 1962, the operation of the drawback scheme for creped paper used in the manufacture of exported adhesive tape,

(c) limits the allowance of drawback under the existing drawback provisions in respect of inked ribbons for typewriters or for other office machinery to ribbons exported on or before 30th June 1963.

The Order comes into operation on the 1st August 1961, and has been published as Statutory Instruments 1961, No. 1393.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under sections 3 (6) and 13 of the Import Duties Act, 1958, viz.:

The Import Duties (Temporary Exemptions) (No. 5) Order, 1961.

The First Schedule to the Order provides for the exemption from import duty from 1st August 1961, to 1st January 1963, or to such other date as is shown in the Order, of certain goods which are at present liable to import duty. The goods affected are mainly chemicals, but include bagasse pulp, unbleached, and stainless steel strip of a certain specification.

The Second Schedule to the Order provides for the continued exemption until 1st January 1962, or to such other date as is shown in the Order, of certain chemicals which are currently exempt from import duty.

The Order comes into operation on the 1st August 1961, and has been published as Statutory Instruments 1961, No. 1394.
