Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

(h) In Notices of Dissolution of Partnership, the signatures of the original partners will not be charged for. NOTE. Should it be necessary for a notice or advertisement to be reinserted owing to advertisers errors in
