The Derby Corporation (No. 2) Smoke Control Order, 1961

1. Notice is hereby given that the Council of the County Borough of Derby in exercise of the powers conferred upon them by Section 11 of the Clean Air Act, 1956, on the 10th day of August 1961, made an Order entitled the Derby Corporation (No. 2) Smoke Control Order, 1961, declaring the area described in the Schedule hereto to be a smoke control area which Order is about to be submitted to the area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation.

Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding $\pounds 10$ unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised

fuels include anthracite, coke and other carbonised fuels, gas and electricity. 3. If confirmed the Order will not come into oper-ation before the 1st day of October 1962, or before a later date determined by the Minister of Housing and Local Government.

Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, The Council House, Corpor-ation Street, Derby, at all reasonable times during the period of six weeks from the 22nd August 1961. 5. Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.
