CITY OF GLOUCESTER The City of Gloucester (Bruton Way) (Prohibition of Waiting) Order, 1961

A further exception will be provided in the Order to enable any vehicle belonging to the Postmaster General to wait between the hours of 5 a.m. and 7 a.m. on the east side of that length of Bruton Way otherwise known as George Street betwen a point 40 feet south from its junction with London Road and a point 160 feet south from the said junction with London Road. This exception will, however, only be in force for a period of three years from the date of the coming into operation of the Order or until the date of completion of the new Post Office Sorting Office, whichever is the earlier.
