The Order also provides that the temporary exemption of certain of the goods described in the Second Schedule shall be construed in accordance with the revised descriptions shown in the Third Schedule.

The Import Duty Drawbacks (No. 9) Order, 1961.

(b) revokes the existing provision for the allowance of drawback of import duty on imported raw silk or waste (excluding noils) used in the production of exported yarn, certain fabrics and made-up articles.
