Subject to the exemptions provided by virtue of section il (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. If confirmed the Order will not come into operation before the 1st September 1962, or before

a later date determined by the Minister of Housing

and Local Government.

#### METROPOLITAN BOROUGH OF ST. PANCRAS

Proposed Parking Places (St. Pancras) (No. 1, 1960) (Amendment No. 3) Order, 1961

Notice is hereby given that the Metropolitan Borough of St. Pancras (hereinafter called "the Council") is applying to the Minister of Transport for an Order, under section 85 of the Road Traffic Act, 1960, to amend the Parking Places (St. Pancras) (No. 1) Order, 1960, as amended (hereinafter referred to "the Order of 1960").

The general effect of the proposed Order is as set

out hereunder:

(a) To provide that the standard periods for which vehicles may be left in certain designated parking places in Gordon Square (north-east and west side), Gordon Street (south of Endsleigh Gardens), Tavistock Square (west side), Endsleigh Pace and Endsleigh Street, Taviton Street and Byng Place and containing a maximum of 185 meters shall be four hours instead of two hours; to provide that the initial charge for a vehicle left to provide that the initial charge for a vehicle left for the standard period of four hours shall be 2s. and that a vehicle may be left for half that standard period for a charge of 1s. Consequential amendments are made to the provisions re-lating to exemptions from charges.

(b) The designation of the parking place numbered 32 in the Schedule to the Order of 1960 is re-voked. A new parking place of increased area is designated in the same highway, namely Percy Mews.

(c) The designation of the parking place numbered 59 in the Schedule to the Order of 1960 is re-voked. A new parking place of reduced area is designated in the same highway, namely Whit-

field Street.

87 in the Schedule to the Order of 1960 is revoked. A new parking place of increased area is designated in the same highway, namely Grafton Way.

(e) Application of the Order of 1960 is extended to an additional parking place for six meters in Whitfield Street, between Maple Street and Howland Street, which is described and numbered 106, in the Second Schedule to the proposed

Order.

The designation of the parking places in Mortainer Market numbered 93 and 94 in the Schedule to the Order of 1960 is revoked.

(g) The Council is authorised to install the parking meters required for the purpose of this Order.

(h) The provisions of the Order of 1960, as varied, well apply to the areas designated as parking placed by the proposed Order.

The Council is also asking the Minister to make amendments to the London Parking Zones (Waiting and Loading) (Restriction) Regulations, 1961, insofar as they relate to cycle parking areas.

The general effect of the proposed amendments is set out becaused as

set out hereunder:

(a) To remove the cycle parking area in Grafton Way numbered 172 in the Regulations.
(b) To remove the position of the cycle parking area in Whitfield Street numbered 190 in the area in Whitfield Street numbered 190 in the Regulations and designate a new cycle parking area in the same highway.

(c) To include in the Regulations two new cycle parking areas in Whitfield Street.

(d) To include in the Regulations two new cycle parking areas in Mortimer Market.
