CONFIRMATION OF PUBLIC PATH ORDER

The Rural District Council of Rochford

Rochford (No. 1) Public Path Diversion Order, 1961

On the 31st day of October 1961 the Minister of Housing and Local Government confirmed with modifications the above Order.

Its effect is to divert the public right of way running from the northern end of the cart track about 450 feet north-west of St. Lawrence and All Saints Church, Eastwood in a north-easterly direction for approximately 800 feet along an existing earth track then turning in a north-westerly direction for approximately 180 feet then in a north-easterly direction for approximately 1,050 feet then northwards for approximately 420 feet to the south-western point of the site of Westbarrow Hall and buildings to a line running from the northern end of the cart track about 450 feet north-west of St. Lawrence and All Saints Church, Eastwood in a north-easterly and then a northerly direction for a total distance of approximately 2,650 feet then turning in a westerly direction for a distance of approximately 580 feet to the south-western point of the site of Westbarrow Hall and buildings.

The old path will be closed at the expiration of fifty days from the 31st day of October 1961.

The Order becomes operative as from the 9th November 1961, but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Highways Act, 1959, or on the ground that any requirement of the Act or any regulation made thereunder has not been complied with in relation to the approval of the Order he may, within six weeks from the date of publication of this notice, make application to the High Court.
