Notice is hereby given that the Brighouse Borough Council in exercise of the powers conferred on them by section 'll of the Clean Air Act, 1956, on the 5th day of February 1962, made an Order entitled "The Borough of Brighouse (Rastrick—No. 7) Smoke Control Order, 1962", declaring the area described in the Schedule hereto to be a smoke control area, which Order is about to be submitted to the Minister of Housing and Local Government for confirmation. for confirmation.

Subject to the exemptions provided by the Order and by virtue of section III (4) of the Act, if, on any date after the Order has come into operation, smoke is emitted from a chimney of any buildtion, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.
- 3. Copies of the Order and of the map referred to therein may be inspected free of charge at the Town Clerk's Office, Town Hall, Brighouse, at all reasonable times during the period of six weeks from the 23rd day of February 1962.
- 4. Within the said period any person who will be affected by the Order may by notice in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London S.W.1, object to the confirmation of the Order.
- 5. It is proposed that the Order shall come into operation on the 1st day of April 1963.
