(a) they are signed or attested by a Solicitor of the Supreme Court, or(b) the Grant of Probate or Letters of Administration relating to the estate to which the advertisement refers is produced for inspection at the time the advertisement is submitted.

Advertisements of Changes of Names will not be inserted unless:

- (a) they are signed or attested by a Solicitor of the Supreme Court, or
 (b) the Praccipe relating to the advertisement is produced for inspection at the time the advertisement is submitted, or
- (c) a duplicate Praecipe relating to the advertisement is produced for retention by the London Gazette Office.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.
