Regimental Sergeant Major DAUDA MUMUNI, 5th Battalion, The Queen's Own Nigeria Regiment.

During the operations for the relief of Austrian Hospital personnel detained by the Kivu Provincial Government at Bukavu a column of vehicles, from which the troops had deployed, came under heavy fire. It became necessary to withdraw the vehicles to a less exposed position. Regimental Sergeant Major MUMUNI, displaying great courage and leadership, successfully inspired the drivers to leave cover, re-enter their vehicles and drive them out of the danger area.
