DRAFT SPECIAL REGULATIONS

Factories Acts, 1937 to 1959

In pursuance of section 129 of, and the Second Schedule to, the Factories Act, 1937, the Minister of Labour hereby gives notice that he proposes to make special regulations imposing requirements for the safety, health and welfare of persons employed in the melting or founding of non-ferrous metals. The regulations will revoke the Regulations, dated 20th June 1908, with respect to the casting of brass.

Copies of the draft regulations, which are entitled "The Non-ferrous Metals (Melting and Founding) Regulations, 1962," may be obtained from H.M. Stationery Office at the addresses shown on the last page of this Gazette or through any bookseller.

Any objection to the draft regulations by or on behalf of persons affected must be sent to the Minister on or before 15th May 1962.

Every objection must be in writing and state—

- (a) the specific grounds of objection; and
- (b) the omissions, additions, or modifications asked for.
