TOWN AND COUNTRY PLANNING ACTS, 1944 AND 1947

Extinguishment of Public Rights of Way County Borough of West Ham

Notice is hereby given that the Minister of Housing and Local Government, in exercise of powers conferred upon him by Section 23 of the Town and Country Planning Act, 1944, as incorporated with the Town and Country Planning Act, 1947, has prepared in draft and proposes to make an Order extinguishing the public rights of way over part of Marcus Street, West Ham.
