"4. Awards of terminal grant and compassionate grant to be as provided in Order in Council (No. 64*/N.P.) of 24th March 1961, Schedule I, section III, except that additional terminal grant may be awarded on or after 1st April 1963, to officers who have been in receipt of awards of retired pay at, or deriving from, the rates in Clause 2 above and who are eligible for revised awards at the rates in, or related to, Clause 3. Such additional terminal grant to be three times the difference between:—

- (a) the annual rate of the retired pay between 1st April, 1962, and 31st March 1963, in respect of retirement on or after 1st February 1962; and
(b) the annual rate of the retired pay due with effect from 1st April 1963.

The amount of additional compassionate grant to be at the discretion of the Admiralty provided that the total amount of compassionate grant paid to any officer shall not exceed three times the annual amount of compassionate allowance in payment to him, as increased on or after 1st April 1963, in accordance with the foregoing clauses.

"5. Awards to officers who revert to the Retired List following re-employment on or after 1st February 1962, to be subject to the general conditions set out in Order in Council (No. 64*/N.P.) dated 24th March 1961, Schedule I, section VIII, the text of which is for this purpose to be regarded as being amended as follows:—

- For the date 1st February 1960, substitute 1st February 1962;
For the date 1st January 1956, substitute 1st February 1960;
For the provisions of Order in Council (No. 47*/N.P.) dated 24th January 1957, substitute the provisions of Order in Council (No. 64*/N.P.) dated 24th March 1961.

"6. The rates of retired pay payable with effect from 1st April 1962 and 1st April 1963, to permanent officers of the Women's Royal Naval Service, and permanent members of Queen Alexandra's Royal Naval Nursing Service of the rank of Nursing Sister and above, who retire from the Active List on or after 1st February 1962, to be 85 per cent. of the rates for male officers of equivalent rank as indicated in Order in Council (No. 64*/N.P.) of 24th March 1961, Schedule II, Clause 1.

SCHEDULE II

"Widows Gratuities

"1. Where on or after 1st February, 1962, a short service officer or a non-permanent Supplementary List officer dies whilst serving on full pay, or where

a permanent regular officer or a permanent Supplementary List officer or a temporary officer serving on terms conferring eligibility for an award of retired pay, dies whilst serving on full pay before having completed sufficient service to make him eligible for an award of retired pay had he been invalided on the day he died, his widow may be granted a gratuity as follows:—

Thence by increments of £80 for each additional year of service which would have reckoned for service gratuity.

"2. Where on or after 1st February 1962, a temporary officer dies whilst serving on terms conferring eligibility for an award of service pension on rating's scales only, or a seaman or marine dies whilst serving on full pay on a regular engagement or short service engagement, his widow may be granted a gratuity as follows:—

Thence by increments of £15 for each additional year of service which would have reckoned for service gratuity.

"SCHEDULE III

"SECTION I

"GRATUITIES FOR SHORT SERVICE MEDICAL AND DENTAL OFFICERS

"1. Any officer entering the Medical or Dental Branches of the Royal Navy on a short service commission of 3 or 5 years' duration on or after 1st May 1961, may, if the full period of Active List service he has undertaken is satisfactorily completed, be granted a gratuity calculated at the rate of £500 for each of the first three years of service and at the rate of £750 a year thereafter.

"2. Medical and Dental Officers entered before 1st May 1961, whose commissions terminate after that date and who have not exercised options to extend
