Barbadoes, July 10.

THE Squadron of Her Majesty's Ships under the Command of Captain Kerr arrived here the 4th Instant, and will proceed to morrow towards the Leeward Islands. Colonel Parke, whom Her Majesty has appointed to be Governor of those Islands, came on board this Squadron, and is gone forward to his Government.

Angua, July 15. Colonel Parke arrived here yesterday, with Her Majesty's Ships the Sheerness and Swan, having left the Squadron of Men of War under the Command of Captain Kerr at Barbadoes. An Irish Vessel from Belfast, having on board 9 Men and 6 Boys, being attacked in sight of this Island by an open Sloop with 50 Men, made so good a Defence, that 40 of the Enemy were wounded, and the Sloop was taken and brought in here.

Jamaica, August 6. Her Majesty's Ships under the Command of Captain Kerr arrived here the 25th of the last Month, and joined the Squadron commanded by Rear-Admiral Whetstone; and they are since put to Sea again. This Island is at present very healthy.

Edinburgh, September 18. His Grace the Duke of Queensberry, Her Majesty's High Commissioner for this Kingdom, arrived here this Day, being accompanied by most of the Nobility and Gentry in and about this City, who met his Grace at several Miles distance out of Town; and he was saluted by a treble Discharge of the great Guns of our Castle, and of the Ships in Leith Road.

Waitehaven, Sept. 18. The 16th Instant several laden Colliers sailed hence for Dublin. Yesterday a small Vessel, which came from Dumfriesshire in Scotland, was (taved to pieces on the back of our Pier, but the Men were saved.

Falmouth, Sept. 21. The 18th Instant the Seven Provinces and the Jealously, two Dutch Privateers, failed hence to cruise. The next Day Her Majesty's Ship the Swiftsure, Captain Griffith Commander, anchored off of this Place; under whose Convoy came 4 small Vessels from the Isle of Wight. The Martha of London, William Buck Commander, arrived here from thence the same Day. Yesterday Her Majesty's Ship the Bound came in, with two Vessels belonging to this Place from Plymouth, and the Sun Dogger of Rotterdam, bound from thence to Londonderry. This Day came in the Hopewell of London, John Baraman Master; the Providence, Joseph Coats Master, from Swanzy; the Sufannah of Middlebourg, bound for Londonderry; the Martha of Dublin, William Robertson Master, homeward bound; and a Danish Ship laden with Deals.

Plymouth, Sept. 22. The 18th Instant came in here Her Majesty's Ship the Eagle from Torbay; The next Day the Friendship, Josiah Ritce Master, from Weymouth; and three Merchant-men from Bristol, bound for Portsmouth; the St. Mary of Scitua from Struckholm; and a small Vessel from Portsmouth, laden with Salt for this Place. The 20th Her Majesty's Ships the Triton, Milford, Drake, Weasel, and Isabella Yacht, failed hence for Torbay. The same Day arrived here the Swift Galley, William Buckley Master, from London; the Janaban, William Mills Master, from Torbay; and four Barges, Matthew Hutchins Master, from Topsham; and a Dutch Privateer from cruising. Yesterday came in the Neptune and John Gallies, bound for Portugal; the Rebecca of Liverpool, laden with Salt from Guernsey; two Ships of and from Ostende, bound for Ireland; four from Amsterdam for Lisbon; the Hull Galley for Leghorne; and a Dutch Vessel laden with Salt.

Dartmouth, Sept. 22. The 20th Instant came in here the Hope from Ostend, bound for Ireland; the Rose of and from London, Elias Harrison Commander; and the Experiment, John Buckley Master, from Sunderland. The Prince Eugene, a Dutch Privateer, failed out of our Road the 19th to cruise. Yesterday 3 of Her Majesty's Ships, which came from Spithead, joined the Fleet at Torbay.

Bristol, Sept. 23. Yesterday came in here the Mary of Protection of St. Malo, a Prize taken the 2d Instant on the Banks of Newfoundland by the Queen Anne Galley, a Letter of Marque Ship, belonging to this Port, which came out of St. John's three Days before, and left there the Prince Eugene of this Port, John Eastmount Commander, who had lately taken at several times 14 Sail of the Enemy's Ships, trading to Newfoundland, most of whom he had ransomed, and put the hostages on board Her Majesty's Ship the Lark, that put in there, with three Men of War more, homeward bound from the West-Indies. The same Day came in the Dorcas Galley, with 4 Sail more, being part of a Fleet that failed from Cork the 20th Instant, under Convoy of Her Majesty's Ship the Bridgewater, which saw them as far as Lundy, and then they were separated by bad Weather. This Day came in the William and Sarah, another Ship belonging to the same

Fleet; the Prince Storeship, that came out of Milford, with several other Vessels, on Thursday last, but was separated from them by bad Weather; and the Stonecage Galley of this Place, Thomas Hodges Master, from Jamaica, but left from Ireland.

Amsterd., Sept. 21. The Bonaventure of Amsterdam, John Bulhouson Master, bound for Leghorne, is lately come in here; as are also several other outward bound Dutch Merchant-men.

Tarmonth, Sept. 23. A Fleet of laden Colliers passed through our Road yesterday to the Southward.

Portsmouth, Sept. 24. Two Dutch Privateers came to Spithead the 20th Instant with 9 Merchant-men, under their Convoy. The next Day came to Spithead divers small Vessels from the Downes.

Windsor, Sept. 23. The Baron of Hohendorf, Adjutant-General to Prince Eugene, being sent by the Duke of Savoy and Prince Eugene to Her Majesty, with the News of the signal Victory obtained by the Confederate Forces under their Command, over the French Army commanded by the Duke of Orleans near Turin, the 7th Instant, N. S. and the raising the Siege of that Place, attended the Queen this Day, and presented to Her Majesty Letters upon that Subject from his Royal Highness and Prince Eugene.
