## WATER ACT, 1945

Notice is hereby given that the Minister of Housing and Local Government is about to make an Order under section 9 (2) of the Water Act, 1945, for the constitution of a joint water board with limits of supply comprising the following areas in the Counties of Lincoln (Parts of Lindsey) and Lincoln (Parts of Holland):

The Boroughs of Boston and Louth,  
The Urban Districts of Alford, Horncastle, Mablethorpe and Sutton, Skegness and Woodhall Spa,  
The Rural Districts of Horncastle, Louth and Spilsby, and  
In the Rural District of Boston, parts of the Parishes of Brothertoft and Fishtoft (i.e. so much of the Rural District as is not within the limits of supply of the proposed South Lincolnshire Water Board).
