 (b) the Practipe relating to the advertisement is produced for inspection at the time the advertisement

is submitted, or (c) a duplicate Praecipe relating to the advertisement is produced for retention by the London Gazette Office.

(d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15s. Other Notices under the Act at rates given under (f).
(e) Deputy Lieutenants Commissions: 10s. for each Commission.
