THE Newcastle Man of War, Captain Cutter Commander, came into this Port the 4th instant from Oneglia, where she had landed a considerable quantity of Powder for the Duke of Savoy's Service. The Count de Verne arrived here the 10th, being sent by the Duke of Savoy to the Duchesses, with the News of the compleat Victory gained the 7th, by the Confederate Army under the Command of his Royal Highness and Prince Eugene, over the French Forces within their own Lines, between the Rivers Dora and Stura: Of which he brings these Particulars; That the Troops of Prussia, which are commanded by the Prince of Anhalt, were the first that forced the Enemy's Intrenchment, whose Horse charged them; but they being supported by the Confederate Horse, and the rest of their Troops at the same time beating the French from their Works, they entirely routed them; and the Enemy fled, part over the Bridge of Paret, and the rest over that of Cavour, leaving behind them all their Artillery, Tents, Ammunition and Bagage. The Marshal de Marin was taken Prisoner, who is since dead of his Wounds. The Duke of Orleans was also wounded. The Duke of Savoy's own Regiment of Horse had taken three pair of Kettle-Drums, and two Standards, besides what were taken by the rest of the Confederate Troops, which were still in pursuit of the Enemy when this Express came away; and at two in the Afternoon they reckoned they had already 3500 Prisoners, among whom were several Officers of Note. There were found in the Enemy's Works 150 Pieces of Cannon, 50 Mortars, vast Quantities of Ammunition and Stores of all kinds, and a great deal of other Booty. A Courier is since come in, by whom we have Advice of further Advantages gained over the French, there being 4500 in all taken Prisoners, about 1000 killed, and 2000 being come over to the Confederates, besides great Numbers who also deserted and made their Escape elsewhere; and the broken Remains of the Enemy's Army being retired towards the French Frontiers: So that we are in Hopes of seeing Italy shortly freed from their Troops, which had almost brought the most flourishing Parts of it to entire Ruin, and the Seat of the War on this side removed into the Enemy's Country. The Duchesses of Savoy, and the Envoy of the States-General to his Royal Highness, who is also in this Place, made great Rejoicings Yesterday for this glorious Success; and the English and Dutch Ships in our Port have made a treble Discharge of all their Guns upon this happy Occasion.

Falmouth, Sept. 23. The Prince Packet-Boat, Peter Leane Master, sailed hence Yesterday with one Mail for Lisbon. This Day came in here two small Ships laden with Coals from Swanzy, which were separated by bad Weather the 20th off the Land's-end from a Fleet of Coasters and other Vessels from Wales, under Convoy of Her Majesty's Ships the Southampton and Lizard.

Plimouth, Sept. 24. Yesterday came in here the Loyal Transport-ship from Biddiford, bound for Rotterdam; a Ship from Chester, and another from Jamaica, bound for London; the Globe from Liverpool for Harwich; six Dutch Merchantmen for Bourdeaux; two Ships from Liverpool, bound hither; and several Colliers for this Place and Topsham.

Bristol, Sept. 25. Yesterday came in here the St. Peter of and from Dram in Norway. The Marlborough Frigat, belonging to this Port, William Fresh Master, arrived here this Day in five Weeks from Anteozos; and the Prosperity from Cork.

Fowey, Sept. 26. Her Majesty's Ship the Fowey, Captain Leitch Commander, arrived Yesterday at Spithead from Alicant, having been three Weeks in her Passage. On board her was Colonel Hamilton, who came from the Earl of Peterborow, and brings an Account of the Surrender of the Castle of Alicant. His Lordship arrived at Alicant five or six Days before she set Sail, having left the Army encamped near Chincon. When the Fowey came away from Alicant, Sir John Lake was gone to water in Altea Bay.

Dissel, Sept. 28. Her Majesty's Ships the Hampshire and Litchfield arrived in the Downes this Day, with several homeward bound Merchant Ships under their Convoy. The Hampshire sailed from Scanderoon the 23d of June last, with the Delawar and the St. George, both belonging to the Levant Company. The 29th of July they joined the Litchfield in Navarino Harbour, with the King William Galley, and the City of Leghorne, a Dutch Merchant Ship. The 31st past they stopped at Gibraltar; and the 2d instant they were joined by the Stratford Frigat, the Happy Return, and the Mary Galley, all three bound for London.
