(a) they are signed or attested by a Solicitor of the Supreme Court, or
(b) the Grant of Probate or Letters of Administration relating to the estate to which the advertisement refers is produced for inspection at the time the advertisement is submitted.

Advertisements of Changes of Names will not be inserted unless:

(a) they are signed or attested by a Solicitor of the Supreme Court, or

(b) the Practical relating to the advertisement is produced for inspection at the time the advertisement

(c) a duplicate Praecipe relating to the advertisement is produced for retention by the London Gazette Office.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

 (b) Notices under the Companies Acts in the standard form prescribed for certain London Gazette notices by The Companies (Winding-up) Rules, 1949, and The Companies (Forms) Order, 1949, Statutory Instruments Nos. 330 and 382 of 1949: 7s. 6d. Other Companies Winding-Up Notices at the rates given under (f).

 (c) Friendly Societies Notices: 7s. 6d.

 (d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: 15s. Other Notices under the Act at rates given under (f).

 (e) Deputy Lieutenants Commissions: 10s. for each Commission.

 (f) All other Notices or Advertisements, including Applications to Parliament and Scotch Sequestrations will be charged by the number of lines appearing as plain matter in the type of the Gazette:
