The QUEEN's Most Excellent Majesty in Council

The QUEEN'S Most Excellent Majesty in Council Whereas a Representation duly made to Her Majesty in Council by the Minister of Housing and Local Government that, for the protection of the Public Health, burials should be discontinued as hereinafter directed in St. Alban's Churchyard, Felling, Gates-head, County Durham, has, in pursuance of an Order in Council made the 14th day of June 1962, and duly published, been taken into consideration by a Committee of the Privy Council: Now, therefore, Her Majesty, in exercise of the powers conferred on Her by section one of the Burial Act, 1853 (16 & 17 Vict. c. 134), and of all other powers Her enabling, is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows: 1. Burials shall be discontinued forthwith and

1. Burials shall be discontinued forthwith and entirely in St. Alban's Churchyard, Felling, Gates-head, in the said County.

Provided that-

- (a) In any earthen grave now existing in the said Churchyard, the burdal may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, sub-ject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
- (b) In the said Churchyard, in any grave space in which no interment has heretofore taken place, the burial may be allowed of the body of any person for whom or of any member of a family for which such grave space has been reserved and appropriated as a burial place, with the

exclusive right of burial therein, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (St. Alban's Churchyard, Felling, Gateshead, County Durham) Order, 1962.
