Its effect is to divert public rights-of-way in the

- (1) The public footpath in the Parish of Stondon Massey commencing on the southern side of the road leading from Chipping Ongar to Stondon Massey, at the entrance of Little Myles's farm-Massey, at the entrance of Little Myles's farmyard, and running south-westerly for 610! feet along Enclosure 23 to the south-eastern corner of Enclosure 21—to be diverted so as to commence approximately 450! feet to the west of Little Myles's farmyard in the north-eastern corner of Enclosure 21 running south for 490 feet inside the eastern boundary and to the south-eastern corner of that Enclosure thence into Enclosure 23, terminating at the same point as at present. at present.

 2) The public footpath in the Parish of Kelvedon Hatch commencing at a stile on the eastern side of the road leading from Chipping Ongar to Kelvedon Hatch, in the north-western corner of Enclosure 88 adjoining The Grange formerly The Rectory, running north-easterly along the northern boundary of that Enclosure for 440 feet continuing across Enclosures 91 and 119 for 1190 feet to the eastern corner of the latter enclosure where it crosses a stream by a wooden bridge into Enclosure 122, across that Enclosure for 320 feet to a wooden bridge and stile on the eastern boundary of that Enclosure, 500 feet to the north of Bushey Wood—to be diverted so as to commence 450 feet south of its present point of commencement, in the south-western corner of Enclosure 91, and 390 feet west of Priors Wood, running easterly and north-easterly for 1110 feet along the southern boundary of Enclosure 91 round Priors Wood to the stream at the eastern corner of the wood, turning northwards with the stream and crossing it by a bridge into Enclosure 122 and continuing along the south-eastern side of the stream for 930 feet to the north-eastern corner of that Enclosure there turning south with the stream for 90 feet inside the eastern boundary of Enclosure 1222 terminating at the same point (2) The public footpath in the Parish of Kelvedon the stream for 90 feet inside the eastern boundary of Enclosure 122 terminating at the same point as at present.
