Notice of intention to make an Order abolishing The Hat, Cap and Millinery Wages Council (England and Wales) and The Hat, Cap and Millinery Wages Council (Scotland) and to establish The Hat, Cap and Millinery Wages Council (Great Britain).

The Minister of Labour hereby gives notice that he intends pursuant to the powers conferred upon him by section 4 of the Wages Councils Act, 1959, to make an Order abolishing the Hat, Cap and Millinery Wages Council (England and Wales) and the Hat, Cap and Millinery Wages Council (Scotland) and establishing the Hat, Cap and Millinery Wages Council (Great Britain).
