*The Trunk Road (Various Streets, Emsworth)
(Prohibition of Waiting) Order, 1962*

The Minister of Transport proposes to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be that no person shall cause or permit any vehicle to wait in that length of the Folkestone — Brighton — Southampton — Dorchester Honiton Trunk Road (A.27) known as West Street, High Street and Queen Street at Emsworth in the Urban District of Havant and Waterloo, which extends from its junction with Bridgefoot Path to a point 140 yards west of its junction with Slipper Mill Lane.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.

AMENDED NOTICE

*The Trunk Road (Coseley, Staffordshire)
(Prohibition of Waiting) Order*

The Minister of Transport proposes to make an Order under section 26 of the Road Traffic Act, 1960, the effect of which will be that no person shall cause or permit any vehicle to wait in that length of the East of Birmingham-Birkenhead Trunk Road (A.4123) at Coseley in the County of Stafford, which lies between its junction with Dimmock Street and a point 330 yards south of that junction.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in

connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein.
