Subject to the exemptions provided by the Order and by virtue of section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the smoke control area the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £10 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels. include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into opera-tion before the 1st day of November 1963, or before a later date determined by the Minister of Housing

and Local Government,
