ROYAL WARRANT OF PRECEDENCE

24th November 1962.

The QUEEN has been graciously pleased to ordain and declare that Frances Mary Elizabeth Ashley-Cooper, Spinster, shall henceforth have, hold and enjoy the same title, rank, place, pre-eminence and precedence as the daughter of an Earl which would have been due to her had her father Anthony Ashley-Cooper, Esquire (commonly called Lord Ashley) survived his father Anthony, Earl of Shaftesbury and thereby succeeded to the title and dignity of Earl of Shaftesbury.

And to command that the said Royal Concession and Declaration be recorded in Her Majesty's College of Arms.
