This Day his Grace the Lord Archbishop, with the Bishops and the rest of the Clergy of the Province of Canterbury, assembled in Convocation, presented the following Address to Her Majesty :

To the QUEEN's most Excellent Majesty.

The humble Address of the Archbishop, Bishops, and the rest of the Clergy of the Province of Canterbury, assembled in Convocation.

May it please Your Majesty,

It is a Happiest peculiar to Your Majesty's Reign, that Your Subjects can, without any Suspicion of Flattery, wait upon Your Majesty every Day with their humble Acknowledgments for the Blessings they receive from Your Auspicious Government.

We are this Year particularly to Congratulate, not a single Victory, but such a Course of Wonderful Success, as can scarce be paralleld in History; such as will make Your Majesty's Reign glorious to all Posterity, and we hope will Reduce that formidable Power, which has so long threaten'd Us and the rest of Europe.

For the Surprising Success in the beginning of this Campaign, we have already offer'd up our Solemn Thanks to Almighty God; and we shall with Hearts full of Joy Celebrate the Approaching Day of Thanksgiving for the Continuance of God's Mercy through the Course of the whole Year, which Your Majesty has most Piously Appointed.

We think it our Duty in the next place to Return our humble Thanks to Your Majesty, whose Zeal for the Common Cause, whose Treasure and the wise Management of it, whose Fleets and Armies, and whose Great General the Duke of Marlborough, have given Life and Spirit to that Alliance, by which, under God, these great things have been brought to pass.

We desire also with all Thankfulness to acknowledge the Blessings we Enjoy at Home under Your Majesty's most Happy Government, that we are free from those great Inconveniences that do too often attend Reigns so eminently Bless'd with Military Success; that our Laws have their free Course; that Justice is equally Administer'd; that our Liberties and Properties are Secured; and that our Religion and our Church are Supported and Encourag'd both by Your truly Christian Principles and Your great Example.

Enjoying these Happy Advantages, we cannot but Acknowledge our Obedience to be in a Safe and Flourishing Condition under Your Majesty's Administration; and we hope that, by the Blessing of God, you will be Enabled to Transmit it Safe to Posterity, since the House so far humbled its greatest Enemy.

May our Good God, who has hitherto made every thing so wonderfully prosper in Your Hands, still continue His Gracious Care and Providence over Your Sacred Person; that You may effectually accomplish all Your great Designs for the Good of these Kingdoms, and afterwards be long Bless'd with a Peaceful Reign over a United, a Dutiful, and a Grateful People.

To which Her Majesty was pleas'd to return the following most Gracious Answer :

My Lords, and the rest of the Clergy,

I Am very much Pleas'd with the Assurance of your Duty and Affection in this Address from the Convocation.

I hope it will have a very good Effect upon the whole Clergy, and all My Subjects in general.

I desire you to be Assured, that I have nothing more at Heart, than to Preserve the Church of England as by Law Established in a Safe and Flourishing Condition.

Milan, Nov. 28. N. S. Prince Eugene is shortly expected here from Pavia. The Castle of this City continues closely block'd up; 104 French and Spaniards deserted from thence in one Day, and great Numbers of them come over to us daily, who report, That the Garrison begins to want Provisions, and several other Necessaries; which we hope will shortly engage them to surrender. The Siege of the Castle of Casal is vigorously carried on, notwithstanding the bad Weather.

Warsaw, Nov. 27. The Saxon Troops are marching to the Winter Quarters assign'd them in Prussia, and in the Palatinate of Cracow: The Muscovites and Cossacks have taken theirs in the Palatinate of Ruffland.

Vienna, Dec. 1. The Duke of Wirtemberg's Deputy received on the 29th past from the Emperor, in the Duke his Majesty's Name, the Investiture of that Duchy. The States of the Lower Austria have under Consideration the raising of a certain Number of new Levies and Recruits which the Emperor demands of them. They write from the Upper Hungary, That General Rabutin continu'd encamp'd along the Thays, expecting further Orders from this Court, which were dispatch'd to him the 27th past, by the Return of an Express he lately sent hither. All possible Care is taken, by putting the Garriſons on the Frontiers of this Province into a good Posture of Defence, and by the posting of regular Forces and Militia in proper places, to secure the Country

Hanover, Dec. 10. The Elector of Hanover returned hither last Night from Guertz, a Place in the Territories of Cell, and 12 German Miles from hence, where he has been taking the Diversion of Hunting. Monsieur d'Oberg, Minister of State to his Electoral Highness, set out from hence the 24th past for Saxony. Major-General Hammerstein is appointed his Envoy to the Court of Denmark, and will soon begin his Journey thither. Mr. Pultency, Her Majesty of Great Britain's Envoy Extraordinary to the King of Denmark, arrived here the 7th Instant in his way to Copenhagen.

Hague, Dec. 14. N. S. Count Falais, Son to the Count de Noyelles, arriv'd here yesterday from Spain: He came from Valentia the 12th of October, together with Monsieur Zinzler the King of Spain's Secretary, and the Count de Lecheraine; embark'd at Barcelona the 28th, and land'd at Genoa the 10th of the last Month. He gives an Account, That his Catholick Majesty arriv'd at Valentia the 2d of October, being accompanied by the Earl of Galway, the Marquis das Minas, Mr. Stanhope Her Majesty of Great Britain's Envoy Extraordinary and Plenipotentiary, and the other General Officers and Publick Ministers; That the English, Portuguese and Dutch Troops, are march'd into Winter Quarters in the Kingdoms of Valentia and Murcia; That Lieutenant-General Wyndham, died at Valentia the 8th, after two Months Illness; and that the King, intend'd shortly to call together the Cortes or States of the Kingdom of Valentia, and afterwards to go to Saragossa, to hold an Assembly of the Cortes of the Kingdom of Aragon. Letters from Madrid of the 22d past, which came by the way of France, say, the Duke of Berwick has taken Carragena; after which he put his Troops into Winter Quarters. They write from the Duke of Savoy's Camp before the Castle of Cazal of the 27th, That they broke Ground before that Fortyes the 25th, and were erecting a Battery of 10 Pieces of Cannon, which would begin to play the 28th; and that they had received Advice, That the Body of Imperialists commanded by General Langaric and Major-General Werzel took the City of Modena by Storm the 18th at Night, Monsieur de Bar, the French Commander there, retiring into the Castle, which was believed could not hold out long. The two Ambassadors sent from the State of Venice to Her Majesty, arriv'd at Cologne the 10th Instant, in their way to England. The States of Holland and Westfriland will meet to-morrow.

Falmouth, Dec. 7. On the 2d Instant fail'd hence two Dutch Doggers for Bourdeaux, and one from thence, laden with Wine for Amsterdam. The Margaret Galley of this Place put into this Port, being bound for London, and laden with Wine from Viana. The 3d was sent in here the Swallow Privateer of Granville, of 16 Guns and 86 Men, taken on the 30th past by Her Majesty's Ship the August. This Day fail'd the Prince George Packet Boat for Lisbon, Capt. White Commander; the Scarborough, James Jameſon, the Goodwill, John Annis, the Port John Clark, and the Royal Ann, Thomas Melmoore, Masters; all bound from London to the Streights, Viana, and Oporto; and the Kingiwellton and Marlborough for Leghorne.

Dartmouth, Dec. 6. The 4th, fail'd from this Place the Resolution Galley, lately come from Gibraltar, and the Real and Banished Gallies, both from Zant, being all three bound for London; and a Dutch Dogger, homeward bound from Faro.

Plimouth, Dec. 8. On the 5th Instant Her Majesty's Ship the Assurance fail'd for Spithead, and a Flushing Capet, homeward bound, with a Prize she has lately taken. The same Day arriv'd here Her Majesty's Ships the August and the Charles Galley from cruising. The 7th fail'd the Page, Tuscan and Volant Gallies, for Leghorne, and two Offenders for Waterford; and came in the Charles Galley from Fowey, with two Tin Ships, and the Anna from Boston, bound for London. Her Majesty's Ships the August and Nontuch fail'd at the same time for Ireland. This Day arriv'd here from Torbay the Lancaster, and 2 Dutch Men of War, with the Welcome from Rotterdam, and the Barbadoes Merchant, belonging to this Place, from Portsmouth.

Tarmouth, Dec. 9. Several of the homeward bound Hamburgh Fleet, that lately put into Hull, are this Day come into our Road.

Portsmouth, Dec. 10. On the 6th Instant fail'd out of our Harbour Her Majesty's Ships the Mary Galley and Sun Prize; as did also from Spithead the Advice, with about 50 Virginia Ships under her Convoy for the Downes. The 7th fail'd from Spithead Her Majesty's Ship the Litchfield, and a Dutch Man of War, with about 6 Sail of Merchant Ships under her Convoy, for Plimouth. The 8th came to Spithead about 30 Sail of Merchant Ships and Coasters, under Convoy of Her Majesty's Ships the Chatham and Adventure, who pass'd by at the same time for the Westward; and the 9th Her Majesty's Ships the Restoration, Winchelsea, and Child's Play.

Deal, Dec. 8. Yesterday Her Majesty's Ships the Winchelsea and Child's Play, with about 30 Sail of outward

and under their Convoy divers homeward bound Virginia Ships, two from New-England, and one from Leghorne, beside several Coasters, arrived there.
