CAMBORNE-REDRUTH URBAN DISTRICT COUNCIL

The Urban District of Camborne-Redruth (Commercial Street, Camborne) (Prohibition of Waiting) Order, 1962.

Notice is hereby given that on the 31st December 1962, the Camborne-Redruth Urban District Council made an Order under the Road Traffic Act, 1960, the effect of which will be that no person shall, except upon the direction or with the permission of a police constable in uniform, cause or permit any vehicle to wait between the hours of 9 a.m. and 6 p.m. on Monday to Saturday inclusive, in each week, during the period 1st June to the 30th September inclusive, in each year, in the length of road specified in the Schedule hereunder.

The Order will come into operation on the 1st June 1963, but exceptions are provided therein to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle; to enable goods to be loaded on to or unloaded from the vehicle; to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, or the maintenance, improvement or reconstruction of the length of road or the services therein; to enable the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road; to enable the vehicle to be used in connection with a funeral.

DEVELOPMENT PLAN FOR THE ADMINISTRATIVE COUNTY OF WARWICK

(Addition of a Green Belt)

Notice is hereby given that the Minister of Housing and Local Government has considered the proposals submitted to him by the Council on the 10th March 1960, for the addition of a Green Belt to the Development Plan for the County of Warwick and proposes to make a number of modifications to the proposals.

At the same time, the Minister has drawn the Council's attention to official studies which are being made of the housing needs and land resources of the

West Midlands, which are showing a very serious problem of finding sufficient land to meet the needs. After carefully considering this situation, the Minister has concluded that it would be premature to give a final decision upon any green belt proposals for the area until the full implications have been assessed. He has meanwhile invited the Council to continue their administration on the basis of their proposals subject to the modifications now put forward.
