Isle of Wight Areas of Outstanding Natural Beauty (Designation) Order, 1963

Notice is hereby given that the National Parks Commission propose to make and submit to the Minister of Housing and Local Government for confirmation the above mentioned Order.

- 2. The effect of the proposed Order, which will not come into operation until confirmed by the Minister of Housing and Local Government, will be to constitute the land to which the proposed Order relates areas of outstanding natural beauty for the purposes of the National Parks and Access to the Countryside Act, 1949.
- 3. The proposed Order relates to land situated in the County of the Isle of Wight and comprises land within the undermentioned districts:

The Municipal Boroughs of Newport, and Ryde. The Urban Districts of Cowes, Sandown-Shanklin, and Ventnor.

The Rural District of Isle of Wight.

- 4. A copy of the proposed Order and of the map referred to therein has been deposited for public inspection at the office of the Council of each of the areas mentioned above, and will be open for inspection free of charge during office hours. Copies may also be inspected at the offices of the National Parks Commission, 1 Cambridge Gate, Regent's Park, London N.W.1.
- 5. Any representation with reference to the proposed Order should be sent in writing to the Secretary, National Parks Commission, 1 Cambridge Gate, Regent's Park, London N.W.1, so as to arrive

not later than the second day of March 1963, and any such representation should state the grounds on which it is made.
