*Speed Limit—Hersham, Surrey*

The Minister of Transport hereby gives notice that he proposes to make an Order under section 11 (1) of the Road Traffic Act, 1962, prohibiting the driving of motor vehicles at a speed exceeding 40 m.p.h. on the length of Esher Road (A.244), Hersham, from its junction with Molesey Road (A.317), to a point 60 yards north-west of Esher Bridge.

The lengths of this road from its junction with Molesey Road (A.317), eastwards for a distance of 120 yards, and from a point 600 yards east of its junction with Molesey Road eastwards to a point 60 yards north-west of Esher Bridge, a distance of approximately 727 yards, are at present subject to a speed limit of 30 m.p.h.
