Advertisements of Changes of Names will not be inserted unless:

- (a) they are signed or attested by a Solicitor of the Supreme Court, or
   (b) the Practipe relating to the advertisement is produced for inspection at the time the advertisement
- is submitted, or (c) a duplicate Practipe relating to the advertisement is produced for retention by The London Gazette Office.

Advertisements relating to Bills before Parliament will not be inserted unless signed by a Parliamentary Agent or a Solicitor of the Supreme Court.

Other Companies Winding-Up Notices at the rates given under (f).

(d) Notices under the Trustee Act, 1925 (Executor and Administrator) in columnar form: £1 2s. 6d. Other

Notices under the Act at rates given under (f).
