This Order, which came into operation on 17th April 1963, further amends the Animals (Landing from Channel Islands, Isle of Man, Northern Ireland, and Republic of Ireland) Order 1955, by extending to swine fever the provisions of Part III of that to swine fever the provisions of Part III of that Order relating to animals in landing places affected, or suspected of being affected, with certain specified diseases. In consequence of the Atrophic Rhinitis (Revocation) Order 1962 (S.I. 1962/2528), the Order also revokes the reference to atrophic rhinitis of swine in the definition of "disease" in the 1955 Order.
