The QUEEN has been pleased to award The Queen's Police Medal for Gallantry to the late Detective Inspector Wallace Chalmers and to the late Detective Sergeant Neville Wilson Power, both of the New Zealand Police, in recognition of their gallant con-duct in the following circumstances:

Additional former, in recognition of a tick guillet construct in the following circumstances: On 6th January 1963, a police party was called to Waitakere on the outskirts of Auckland where a man was insanely and indiscriminately firing a rifle. One person had been fatally shot and another severely wounded. When the policy party arrived the offender refused to answer requests to surrender issued over a loud haller. Detective Sergeant Power moved in closer and ordered the man to come out. When the instructions over the haller were met with rifle shots the Detective cautiously advanced and fired tear gas through a window. As a result the offender rushed out and mortally wounded the Detective by a shot fired through the corner of the building. In rushing away to avoid the tear gas the offender aimed his rifle at another police officer. Inspector Chalmers, observing this, called upon the rifle to be turned upon himself and was fatally shot when he endeavoured to avoid the aim.
