(a) Notices under the Bankruptcy Act, 1914 or the Bankruptcy Rules, 1952: 10s. 0d.
(b) Notices under the Companies Act, 1948:

(i) Notice of Appointment of Liquidator pursuant to Section 305 of the Act and the Companies (Forms)
Order, 1949 (S.I. 1949 No. 382): 10s. 0d.

(ii) Notice of Advertisement of Petition pursuant to Rule 28 of the Companies (Winding-up) Rules, 1949
(S.I. 1949 No. 330): 10s. 0d.

(iii) Notice pursuant to the Companies (Board of Trade) Fees Order, 1963 (S.I. 1963 No. 467): 10s. 0d.

(iv) Other Companies (Winding-up) Notices at the rates given under (f).

(c) Notices pursuant to the Friendly Societies Act, 1896 and the Industrial and Provident Societies Act, 1893: 10s. 0d.
