## PRIVY COUNCIL OFFICE

At the Court at Buckingham Palace, the 2nd day of May 1963.

PRESENT

The QUEEN'S Most Excellent Majesty in Council Whereas there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 1st day of May, 1963 (N.P. 1066/63) in the words following, viz.:

viz.: "Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such conditions and provisions as are from time to time directed by Order in Council: "Ard whereas by Order in Council of 15th

"And whereas by Order in Council of 15th February, 1957, it was provided that Recruiting Officers in the Naval Recruiting Service should have the status of Sub. Lieutenant (S.D.) R.N. or 2nd Lieutenant (S.D.) R.M.:

"And whereas it is thought expedient to alter the title of the R.N. Recruiting Service:

"And whereas it is thought expedient to alter the title of the Recruiting Staff Officer and the title and status of the Recruiting Officer:

"And whereas it is thought expedient to alter the title of the Recruiters I and II:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the proposals set out in the accompanying Schedule to have effect from the dates set out therein:

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals:

" SCHEDULE

"1. Change of title From 1st April, 1963, the title Naval Recruiting Service shall be changed to Naval Careers Service. "2. Change of title of Ranks

From 1st April, 1963, the following changes shall be made;

- (a) Recruiting Staff Officers to be known as Regional Careers Staff Officers. No change is to be made in the status, pay or uniform of these officers.
- (b) Recruiting Officers to be known as Lieutenant (Careers Service). These officers are to have the status, equivalent to and wear the uniform

of Lieutenants (S.D.) Royal Navy or Lieutenants (S.D.) Royal Marines. Their pay and allowances will be as set out in Clause 3 below.

(c) Recruiters I and II to be known by the rank held whilst in the regular Royal Navy or Royal Marine service but with the suffix (Careers Adviser). Recruiters who had on entry to the Recruiting Service, held the rating or rank of Petty Officer R.N. or Sergeant R.M. will be advanced or promoted to Chief Petty Officer or Colour Sergeant Colour Sergeant.

"3. Pay and allowances

(a) Lieutenant (Careers Service)

(i) Pay

From 1st April, 1963, pay will be at a flat rate of  $\pounds 2$  14s. 6d. a day.

(ii) Marriage Allowance The daily rates will be:

From 1st April, 1963, the officers will be entitled to all forms of allowance as for other Lieutenants Royal Navy or Royal Marines.

(iv) Ratings' emoluments

From 1st April, 1963, the officers will cease to be entitled to those forms of ratings' emolu-ments to which they previously had entitlement. They will also cease to be eligible for the Royal Naval Long Service and Good Conduct Medal and the associated monetary awards.

(v) Retired Pay

From 1st April, 1963, the officers will be eligible for retired pay at the scale and under the conditions appropriate to a Lieutenant (S.D.) Royal Navy subject to the maximum laid down.

(b) Careers Advisers

From 1st April, 1963, ratings and other ranks will be entitled to the pay and allowances of their rank as for other personnel entered on engage-ments for restricted service. They will not, how-ever, be eligible for Trade Pay, Charge Pay or Technician Pay."

Her Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of Her Privy Council to approve of what is therein proposed.

And the Right Honourable the Lords Commis-sioners of the Admiralty are to give the necessary directions herein accordingly.
