PUBLIC SCHOOLS ACT, 1868

THE GOVERNING BODY OF ETON COLLEGE having on THE GOVERNING BODY OF ETON COLLEGE having on the 18th day of May 1963, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the said College, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act. And Notice is hereby civen that any parson body

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE made by the Governing Body of Eton College on the 18th day of May 1963.

Statute to alter and amend the Statutes of Eton Statute to after and amend the Statutes of Eton College which amending Statute having been duly made at a Meeting held at Eton on the 18th day of May 1963 of the Provost and Fellows of Eton College (the said Provost and Fellows being the new Govern-ing Body of the said College for the purposes of the Public Schools Act, 1868, and the Acts amending the same) and passed at such Meeting by a majority of votes of the Members present and voting is now submitted for the approval of Her Majesty in Council. We, the Provost and Fellows of Eton College being the new Governing Body of the said College (hereinafter called "the College") for the purposes of the Public Schools Act, 1868, and the Acts amend-ing the same in pursuance of the power given to us by the 11th Section of the Public Schools Act, 1868 (and of all other powers us bereunto enabling) to

(and of all other powers us hereunto enabling) to alter the Statutes made under that Act and the Acts amending the same in relation to the College do hereby amend the Statutes of the College by the addition of the following Statutes.

STATUTE XIVB

(1) The Provost and Fellows and their successors shall from time to time have (in addition to all other powers vested in them by these Statutes or by law) full power to lease all or any part or parts of the College Estates or any estate interest easement right or privilege of any kind in over or in relation to the same for any purpose whatever whether involv-ing waste or not for any term not exceeding

- (a) in case of a building lease ninety-nine years
- (b) in case of a mining lease sixty years
- (c) in case of any other lease twenty-one years.

(2) Subject as hereinafter provided every such lease shall be by deed and be made to take effect in possession not later than twelve months after its date. Every lease shall reserve the best rent that can reasonably be obtained regard being had to any fine taken to any provision for the revision or increase of the rent and to any money faid out or to be laid out for the benefit of any land belonging to the College and generally to the circumstances of the case and shall contain a covenant by the lesse for pay-ment of the rent and a condition of re-entry on the

ment of the rent and a condition of re-entry on the rent not being paid within a time therein specified not exceeding thirty days. (3) A counterpart of every such lease shall be executed by the lessee and delivered to the Provost and Fellows of which execution and delivery the execution of the lease by the Provost and Fellows shall be sufficient evidence. (4) A Statement contained in a lease or in an indorsement thereon signed by or on behalf of the Provost and Fellows respecting any matter of fact or of calculation under this Statute in relation to the lease shall in favour of the lessee and of those claiming under him be sufficient evidence of the matter stated. matter stated.

(5) Any fine received by the Provost and Fellows on the grant of any such lease shall be invested or applied in or for any of the investments or purposes for which the Improvement Fund constituted by the Statute entitled "Scheme for the Improvement of the Property of Eton College" made by the Gov-erning Body of the College on the 11th July 1904 and approved by His late Majesty King Edward VII on the 24th October 1904 is thereby authorised to be invested or applied and pending such investment
