COAST PROTECTION ACT 1949 RURAL DISTRICT OF CHICHESTER

Platt, Kent

The Minister of Transport hereby gives notice that he has made an Order under section 153 of the above Act entitled "The Stopping up of Highways (County of Kent) (No. 17) Order 1963" authorising the stopping up of a length of footpath at Back Lane, Platt, near Borough Green, Kent, and requiring the provision of two new footpaths and a new road, which matter was the subject of a local inquiry held at the Platt Memorial Hall, Platt, on the 27th March 1963.
