Its effect is to divert part of the footpath from South Road to Upper Holway Road, commencing approximately 216 yards from the path's commencement in South Road at the point marked "A" on the map, South Road at the point marked "A" on the map, running in a roughly north-easterly direction crossing field O.S. 474 and field O.S. 473 between points "B" and "C" on the map, thence in a roughly easterly direction passing Hillyfields Cottages to Upper Holway Road at the point marked "D" on the map, to a new section of footpath commencing at the point marked "A" on the map and running parallel with the southern boundary of field O.S. 474 to point "E" on the map, thence in a north-easterly direction to points "B" and "F" on the map, then turning in a southerly direction to the point then turning in a southerly direction to the point marked "G" on the map and then running parallel marked "G" on the map and then running parallel to the southern, eastern and south-eastern boundaries of field O.S. 473 between the points "H"-"J"-"K""L" and "M" on the map and finally passing along the north-western boundary of Hillyfields Cottages, being six feet distance therefrom to Upper Holway Road at the point marked "D" on the map. The old path will be closed and the new path will be available for use on the 27th July 1963.

## EPPING AND ONGAR RURAL DISTRICT COUNCIL

Rural District Council of Epping and Ongar (Willingale) Public Path Diversion Order, 1963

Notice is hereby given that on the 2nd July 1963, the Minister of Housing and Local Government confirmed, with modification, the above Order.

Its effect is to divert public rights of way in the Parish of Willingale as follows:

1. The public footpath in the Parish of Willingale commencing on the south side of Shellow Road on the northern boundary of enclosure 42 opposite the entrance to Torrells Hall and approximately 270 feet west of Pound House, running in a southerly direction for a distance of approximately 1.690 feet across for a distance of approximately 1,690 feet across enclosure 42 entering enclosure 44 at the north western corner thereof continuing inside the western boundary of enclosure 44 to the south western corner of that enclosure, continuing into and across enclosure 39, entering enclosure 183 and continuing to the south western corner thereof, east of Wilkingale Rectory—to be diverted so as to commence on the south side of Shellow Road in the north eastern corner of enclosure 42 immediately west of Pound House and running in 42 immediately west of Pound House and running in a southerly direction alongside the western boundary of Pound House, then continuing across enclosure 42 for a distance of approximately 270 feet into enclosure 44, continuing in a southerly direction inside the eastern boundary of enclosure 44 for a distance of approximately 690 feet to the south eastern corner thereof, entering enclosure 39, turning east and running inside the northern boundary of that enclosure for a distance of approximately 80 feet to the north eastern corner thereof, turning south and continuing inside the eastern boundary of enclosure 39 for a distance of approximately 430 feet to the south

The public footpath in the Parish of Willingale commencing at the north eastern corner of enclosure 185 to the east of Willingale Rectory, running in a south westerly direction across enclosure 185 for a distance of approximately 820 feet to the north western corner of enclosure 187 where it connects with a flootpath running from the Bell Inn to Wood Lane—to be diverted so as to commence in the north eastern corner of enclosure commence in the north eastern corner of enclosure 185 to the east of Willingale Rectory and running in a southerly direction for a distance of approximately 740 feet inside the eastern boundary of enclosure 185 to the south eastern corner thereof where it enters enclosure 187a and joins the existing footpath running

from the Bell Inn to Wood Lane. (All references to enclosure numbers are those as shown on Ordnance Survey Essex (New Series) Sheet L.ld 1.10 (Edition of 1920)).

In both cases the old paths will be closed on the 31st July 1963.
