FACTORIES ACT 1961

The Lifting Machines (Particulars of Examination) Order 1963

On 9th August 1963, in pursuance of subsection (2) of section 27 of the Factories Act 1961, the Minister of Labour made the Lifting Machines (Particulars of Examination) Order 1963.

This Order which comes into force on 21st August 1963, revokes the Cranes and other Lifting Machines Order 1938. It prescribes the particulars of an examination of a crane or other lifting machine which must be entered in the register required to be kept under section 27 of the Factories Act 1961. The information enables H.M. Factory Inspectors to check whether or not the provisions of the Factories Act
