3. The Bills will be issued and paid at the Bank of England. 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates

Separate Tenders must be longed for but of allow of dates. 5. Tenders must be made through a London Banker, Discount House or Broker. 6. Notification will be sent by post on the same day as Tenders are received to the persons whose Tenders are accepted in whole or in part and payment in full of the amounts due in respect of such accepted Tenders must be made to the Bank of England by means of cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 11.30 a.m.) on the day on which the relative Bills are to be dated. 7. Members of the House of Commons are not precluded from tendering for these Bills.

The Lords Commissioners of Her Majesty's Treasury hereby give notice that they have made an Order under section 203 of the Customs and Excise Act 1952, viz.:

The Hydrocarbon Oil Duties (Drawback) (No. 3) Order 1963.

This Order replaces the Hydrocarbon Oil Duties (Drawback) (No. 4) Order 1961, which allowed draw-back in respect of hydrocarbon oil used as a solvent in the manufacture of certain cellulose acetate and of in the manufacture of certain cellulose acetate and of articles made wholly or mainly of such cellulose ace-tate. The present Order extends the drawback to include hydrocarbon oil used also as an extractant in such manufacture, and increases the rate of draw-back allowed. The Order comes into operation on the 26th August and has been published as Statutory Instruments 1963, No. 1419.
