ARCHITECTS (REGISTRATION) ACT, 1931

Regulations made by the Architects Registration Council of the United Kingdom under section 13 of the above-mentioned Act have been submitted for the approval of the Privy Council and are published herewith.

Representations by persons to whom the Regulations are applicable may be made in writing to the Privy Council Office on or before the 7th day of October, 1963.

REGULATIONS MADE IN PURSUANCE OF SECTION 13 OF THE ARCHITECTS (REGISTRATION) ACT, 1931, AMENDING THE EXISTING REGULATIONS.

(a) Delete existing Form "E" and substitute new Form "E" as follows:-

to be completed by an applicant who has qualified for admission to the Register of Architects by passing an examination in architecture which is for the time being recognized by the Architects Registration Council under Section 6(1)(c) of the Architects (Registration) Act, 1931. FORM E

The form when duly completed should be returned to the Registrar, together with the sum of £1 ered in payment of the Admission Fee. This sum will be returned to the applicant if the application tendered in payment of the Admission Fee. is refused.
